**Ordinance #2020- 005**

**(Duly Adopted September 1, 2020)**

**AN ORDINANCE ESTABLISHING REGULATIONS AND RESTRICTIONS ON  
PARKING AT THE FREEMANSBURG BOROUGH MUNICIPAL COMPLEX AND  
PRESCRIBING PENALTIES FOR VIOLATING THIS ORDINANCE**

**WHEREAS**, Borough of Freemansburg is a Borough pursuant to Pennsylvania's Borough Code codified at 8 Pa. C.S. Sections 101 *et seq.*; and

**WHEREAS**, The Freemansburg Municipal Complex located at 600 Monroe Street, Freemansburg Pa. is a municipally owned property, and

**WHEREAS**, parking on subject property is provided for persons having official business at the Municipal Building, Municipal Police Dept., Freemansburg Volunteer Fire Co. Number 1 and special events as authorized by the Borough; and

**WHEREAS**, the parking areas surrounding the Municipal Complex were designed to accommodate vehicles of persons having official business in, or attending a special event in the building or on the property; and

**WHEREAS**, experience has shown that persons, who are not conducting business at the Municipal Complex, with the Borough of Freemansburg have parked their vehicles, sometimes for extended periods of time in the parking lot at the municipal complex, rendering the space(s) unavailable for persons legitimately conducting business at the building; and

**WHEREAS**, it is the desire of Borough Council to ensure that adequate parking is available at the Municipal Complex and that unauthorized persons do not use, park or store vehicles on the property all while preserving public safety; and

**WHEREAS**, It is the desire of the Borough to eliminate conflict and restrict parking by unauthorized vehicles; and

**WHEREAS**, the area of the Proposed parking restriction is the property known as 600 Monroe St. Freemansburg, Pa.:

**WHEREAS**, the following restrictions shall apply to all vehicles:

Parking shall be limited to municipal vehicles and equipment, persons actively conducting business with the Borough of Freemansburg or Freemansburg Volunteer Fire Co. No. 1 personnel at this location and persons attending authorized special events. All others will be ticked and/or towed.

**NOW, THEREFORE, BE IT ENACTED AND ORDAINED BY COUNCIL OF THE BOROUGH OF FREEMANSBURG, NORTHAMPTON COUNTY, PENNSYLVANIA, as follows:**

**PROHIBITED PARKING.** Parking in the aforementioned location shall be restricted as noted.

**FINES AND PENALTIES.**

- A. Any person who shall violate this Ordinance shall, upon conviction thereof, be sentenced to pay a fine of Twenty-five Dollars (\$25). Each violation or each day a violation occurs or continues shall be a separate violation. Violations also subject to removal by towing of vehicle, at vehicle owners expense pursuant to \_\_\_\_\_ of the Pennsylvania Motor Vehicle Code.

**SEVERABILITY.**

If any provision, paragraph, work, section or subsection of this Ordinance in invalidated by any court of competent jurisdiction, the remaining provisions, paragraphs, words, sections, or subsections shall not be affected and shall remain in full force and effect.

**ENFORCEMENT.**


Any Borough police officer, or Borough code enforcement officer is hereby authorized to act on behalf of the Borough to enforce this Ordinance.
